

I toured the area back in September and visited four different hotels and had the opportunity to take a number of tours to see what our membership might like to do and try to find the hotel that would best fit

the needs of the Robert E. Lee Association. It was our decision to accept the proposal of the Embassy Suites as our location. The Hotel is near the Nashville Airport and only a short drive to Downtown Nashville, Grand Ole Opry and other exciting places to visit. I'm confident that you will be
